### **Bulk Grant Claim Uploads**

A new version of the bulk grant upload claim form has been issued. The key issues encountered with the earlier version have been addressed. Updated guidance has been published to support employers. Any employer encountering ongoing technical issues can request assistance through the dedicated email address: <u>levygrant.online@citb.co.uk</u>

- CITB Training Group Funding Steve Taylor gave an overview of the Training Group funding accessed through CITB.
  - CITB Admin / Support Grant for Independent Training Groups (April 2019 Mar 2020) total £28,000
     Despite approval for payment being granted for the Q1 / Q2 periods the £14,000 payment remains unpaid.

    Steve Taylor to liaise with our CITB Local Manager Richard Thorpe to chase payment. Action ST
  - CITB Additional Grant for Independent Training Groups (April 2019 Mar 2020) total £43,740 An update on the use and status of grants accessed from this fund were provided;
    - Training £23,540 (only 50 % available throughout the first 6 months). Claims Apr – Aug 19 total £8,299 forecasted September increases this to £10,420 which is about in line with the allocated limit of £11,770. It is anticipated that a greater demand for training exists in the Autumn & Winter months. Clarity to be sought if the balance available can be used. Action ST
    - Careers activity £20,200
      - Construction Skills & Careers events £5,400 (total claimed to-date £891)
      - School Careers Engagements £2,400 (no claim submitted)
      - HMP Work Readiness programme £8,800 (no claim submitted)
      - Work Experience / Recruitment programme £3,600 (total claimed to-date £480)

Steve Taylor provided an update on each of the Career Activity funds reitterating the requirements to qualify for the Work Experience fund. As long as the work experience opportunity has been a minimum of 5 days and details of the individuals name, dates of experience, activity/trade, last or current provision ie college/school and years group or course, progresssion if any from the experience. A payment of £60/placement can be accessed, maximum of 5 placements per company within the funding year. Although not a large sum of money it may just aid some PPE or transportation cost?

The potential to run a Women into Construction event is being discussed with Grantham College for the 19<sup>th</sup> March 2020. SLGTA to explore the scope for accessing funding through the recently announced CITB Careers Theme fund. The target audience are Influence the influencers and Students aged 9-13 (pre GCSE). Steve Taylor to progress talks with Grantham College and associated funding opportunities. *Action ST* 

### > Training Schedule:

The following data for the calendar year so far was shared with those attending;

- 376 Training outcomes achieved from 102 courses accessed through SLGTA
- £42,822 spent on training
- £20,143 claimed back from CITB grant
- £23,485 invoiced to members for training

Steve Taylor highlighted the fact that the charges made to members for training along with the grant claims to CITB have contributed to the monies spent on training.

The 2 **Mental Health First Aid (2 day)** courses held in June and July were very well received. In total 19 delegates passed the course, some of the feedback received commented;

- "One of the best courses I have attended to date, I feel I have learnt many skills to help me deal with Mental Health in the workplace and in my personal life"
- "Anyone that doesn't understand Mental Health should attend this course as it gives a thorough insight into the topic. It really shows the importance of having a Mental Health First Aider in the Workplace".

Another course date has been set for the 11<sup>th</sup> & 12<sup>th</sup> December @ Boston. The cost to 'in-scope' members is £70/person which equates to the CITB Grant eligibility (Tier 2) for this training.

Congratulations were passed on to Barbara Mehew who delivered the training. Barbara has now been approved by MHFA England to deliver the Adult MHFA Half Day awareness course. A course date to be set for early in the New Year. Action ST

As part of the current Scaffold Skills Shortage group meetings a lot more Scaffold focused training has been accessed. With the account set up with Safety & Access there has been increased take up with the following:

- 2 day CPD refresher
- CISRS 3 day Basic Scaffold Inspection
- Scaffold Appreciation / Awareness
- Scaffolding Estimator course.

A new course for 'Non-scaffolders' has been developed CISRS BASE course designed to train those who erect, alter, dimantle simple scaffold structures. *Appendix 1 – BASE course overview* 

The Training Schedule details courses on offer up until the end of the year, Some of the less frequenty run are available such as SEATS (Site Environmental Awareness – 1 day course) 10<sup>th</sup> October, SSSTS Refresher (1 day course) 10<sup>th</sup> December, these can be viewed via this <u>web-link</u>. #### Government Apprenticeships Levy

Alison Fox – Vice Principal Partnerships & Skills New College Stamford kindly attended the meeting to provide an update on the Government Levy. The informal presentation enabled interaction with attending members to help better understand aspects of funding use, it's limitations and the transfer up to 25% of their levy fund to non-levy paying employers to support training of apprentices.

All employers will have to register for a Digital Account by April 2020. Management can be undertaken by your provider or yourself.

A copy of a more formal presentation is to be distributed with these minutes. Alison Fox stated that employers local provider should be able to assist with the process, but offered the support of New College Stamford where appropriate. #### Mel Reid (Cathedral Training Ltd)

- The North Sea Camp Work readiness programme is finally set to start from October, the programme of delivery has been increasd to try and offset some of the delays the programme has experienced
- The delivery of Groundworks apprenticeships has received approval from CITB, please contact Cathedral Training driectly for more information
- Assessment Infrastucture funding of 11 NVQ Assessors has nearly been filled. We have 2 places available and are ideally looking for 1 more Demolition and 1 more Plant Maintenance. Currently have 9 signed up;
  4 x Plant Operatives, 3 x Plasterers, 1 x Demolition and 1 x Plant Maintenance.

#### Janette Meeney (Messenger Construction)

Janette shared with the group that following the success of their Taster Days in Heritage Plastering and Slate Roofing, they had quite a few applications for each bursary placement. They interviewed 6 people for Heritage Plastering and 5 people for Slate Roofing. They then narrowed this down to 4 people (2 on each course) who came over for a day's work experience with their mentors. They have now been able to offer one applicant for each course a 12 month placement with Messenger Construction Ltd. The Heritage Plastering trainee started on Monday 16th September and the Slate Roofing trainee will start on Monday 30th September.

#### **Steve Taylor**

- Just to re-itterate that the Governments implementation of the Reverse VAT charges in the Construcction Industry has been deferred until October 2020. It is hoped that CITB will still be able to have a guest speaker at the Local Forum (5<sup>th</sup> December Sleaford) to provide greater clarity on this topic.

# The Basic Access System Erector (BASE) **Course Specification**

Duration: Five Davs

- Attendees: This 5 day course is for non-scaffolders, who erect, alter and dismantle simple system scaffold structures within restricted environments.
- Objectives: You will learn on a specific type system scaffold erected to a maximum height of six metres with public interface. On successful completion of the course we will apply on your behalf for the CISRS Basic Access System Erector (BASE) Card in the specific system scaffold product.

#### Theoretical Content:

- SG4- Inclusive of SG19 and Harness Training.
- General Scaffold Knowledge •
- SG6- Manual Handling

#### Practical Elements:

Erect independent scaffold with:

- return and platform extension brackets
- loading bay
- Both ladder and stair access to a maximum height of six metres using the approved system you have trained in.

#### Teaching and assessment

- This course is combination of classroom-based theory and practical exercises. .
- The final assessment involves both written and practical tests.
- Note: Delegates wishing to book one of these courses will be required to have a CITB HS&E Test (or accepted exemption) in place at the time of booking. The CITB HS&E Test (or accepted exemption) needs to have been passed within the previous 23 months before the course start date.

The qualification is valid for 5 years and is renewed by attending a two-day CISRS SSPTS Course in the relevant system.

# A five step framework to building mental health in construction

The Lighthouse Construction Industry Charity, founder of 'Building Mental Health', an online portal set up by active industry volunteers discusses the five-step framework to

help the construction sector develop a positive mental health culture The <u>Lighthouse Construction Industry Charity</u> is the only charity that provides financial and emotional support to the construction community and their families. Building Mental Health provides a 24/7 Construction Industry Helpline which is the first point of contact to access a range of completely free and confidential support services including;

- Emergency Financial aid to construction families in crisis
- Advice on welfare and mental wellbeing
- Support on legal, tax and debt management matters.

Last year the charity's helpline received 1,662 calls and provided £1.25m of support to construction families in crisis. This year they are seeing a huge increase in demand for their charitable services and rely heavily on the generosity of those within the industry to 'help their own'.

#### The five-step framework

#### 1. Commit to making a difference

Change in the workplace starts with your management. Sign the Building Mental Health Charter and make a commitment to improving mental health in our industry.

#### 2. Introduce a helpline

If you haven't already got an Employee Assistance Programme, order your Construction Industry Helpline Pack, which lets your staff know where they can turn to with promotional posters and wallet-sized cards. Order a helpline pack: <u>www.contrusctionindustryhelpline.com</u>.

Alternatively, you can download the Construction Industry Helpline App which is a preventative tool providing support and guidance on a range of physical and mental wellbeing issues. The app can be downloaded free of charge from the app store or google play.

#### 3. Deliver a mental health toolbox talk

The talk should last about 1 hour and should be presented to all employees to raise understanding of the issues surrounding mental health and the importance of starting a conversation and talking. Try to make it interactive. **Download a free Tool Box Talk** and adapt according to your needs: <u>www.buildingmentalhealth.net</u>.

#### 4. Deliver mental health training - half or one-day awareness course

This opportunity should be made available to anyone who might need more information on mental wellbeing, i.e. managers, foreman or supervisors. This gives a more in-depth understanding of mental health and will provide some tools for colleagues to help signpost individuals who are struggling to get appropriate help. #### 5. Ensure you have enough mental health first aiders for your place of work

Set a policy within your company to have a healthy ratio of certified Mental Health First Aiders for every worker or contractor on site. Staff can be trained and certified through a nationally recognised course which usually lasts 2 days.
